

**CONNOISSEUR MEDIA LONG ISLAND'S HOME IMPROVEMENT  
SWEEPSTAKES WITH ISLAND FEDERAL  
OFFICIAL CONTEST RULES**

CMLI hereinafter referred to as the "Station" or "Stations"

No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.

**1. Promotion Dates**

*The Station, owned and/or operated by Connoisseur Media, LLC (CONNCOS) is running a station or multi-station promotional contest (the "Contest") beginning on or about May 3, 2025 at 12:00 am EDT and ending on or about May 18, 2025 at 11:59pm EDT (the "Promotion Dates"). Grand Prize winner or winners will be announced on or about May 20, 2025.*

**2. Entry / How To Win**

- a. *Contestants will be invited to visit the enter to win page, which they will be directed to either by scanning a QR code at an official qualifying event or visiting [www.longislandhomeandgardenexpo.com](http://www.longislandhomeandgardenexpo.com) during the promotional period.*
- b. *Once a contestant gains access to the official enter to win page (<https://lihomeandgardenexpo.com/home-improvement-sweepstakes/>), they must complete an official entry form by entering all of the required information (which includes but is not limited to their name, email, phone number and date of birth and address of residence.) and clicking SUBMIT at the bottom of the page.*
